#### TOWARDS GENDER - FOCUSED ELECTORAL REFORMS

As recommended in the final report of Gender Election Observation Mission (GEOM) 2014 Tunisia, 300.000 women, mostly living in rural areas, who have been excluded from the electoral process need to be given access to the vote for any future elections in Tunisia. The fact that these 300.000 women lacked the official identity card necessary to cast their vote reveals a gap in Tunisia's democratic system, especially for those committed to the gender parity agenda.

### GENDER CONCERNS INTERNATIONAL INVITED TO OBSERVE ELECTIONS IN MOROCCO

### The National Human Rights Council of Morocco calls for reforms ahead of elections

The National Human Rights Council (CNDH) has officially invited Director Sabra Bano to send Gender Election Observation Mission (GEOM) to observe and report on free and fair elections in Morocco. Expressing her gratitude to the invitation of Mr. Driss el-Yazami - Chairman and admiring the work of CNDH, Ms. Bano has responded positively to this honourable invitation by confirming that a Pre Need Assessment Mission will visit Morocco before the beginning of Ramadan to determine the scope and scale of the Gender Election Observation Mission 2015 and 2016 in Morocco.

The National Human Rights Council (CNDH) and civil society organisations in Morocco are demanding constitutional and electoral reforms as the country moves towards municipal elections scheduled for autumn 2015, followed by general elections in 2016.

The crucial role of women in families was highlighted at a Bayan II event on 15 May, the International Family Day. The event was organised by partner organisation Afghan Women and Children Organisation (DSAWCO) by opening the discussions on the role of women in families. At this occasion many families that lived apart were united and Family photos sessions were organised to promote women's presence in Afghan family photos. Program included interactive activities engaging male family members on taking their responsibilities within the family, equality in gender, and children's rights and their notion about family unit in contemporary Afghanistan.

The event drew particular attention to the importance of women in the family and community. An open panel discussion followed about family and youth, which drew attention to the importance of family units and the necessity of a gender-equal society accepting women's inclusion at all levels in Afghan society..

The Bayan II project – *Inclusive Governance and Improved Security through Policy Influencing in Afghanistan* is a consortium with Gender Concerns, two Dutch and seven Afghan partner organisations supported by the Ministry of Foreign Affairs of the Netherlands.

### MYANMAR PRE-ELECTION MISSION FINDS OPPORTUNITIES OF SUPPORT

As a follow-up to an invitation from the Union Election Commission of Myanmar, a delegation of Gender Concerns International experts conducted a Pre-Election Needs Assessment Mission (PNAM) to Myanmar in May. The PNAM delegation assessed the needs and opportunities for launching a Gender Election Observation Mission (GEOM) to work directly with local women's organisations to promote inclusive governance and female leadership.

Assessment mission meetings were held with various stakeholders from the international diplomatic community, the Union Election Commission, and women's and civil society organisations. The PNAM revealed a lack of a gender-specific democracy programme, while there is recognition of a crucial need to support women's electoral participation through a focused initiative such as the GEOM.
